### EXECUTIVE ORDER NO. 35 Series of 2025

#### AN ORDER CREATING THE SEARCH AND SELECTION COMMITTEE FOR THE PAGKILALA SA 75 SIMBOLO NG NATATANGING ORIENTAL MINDOREÑO, PROVIDING FOR THEIR DUTIES AND FUNCTIONS, AND FOR OTHER PURPOSES

**WHEREAS**, the Provincial Government of Oriental Mindoro ("PGOM") recognizes the Province of Oriental Mindoro as a home to individuals with exceptional creativity and excellence in various fields such as education, arts, sports, and public service;

**WHEREAS**, there is a need to continuously pursue individual excellence, which, through community efforts, contributes to the overall growth and development of Oriental Mindoro;

**WHEREAS**, multisectoral recognition and support are vital to nurturing talents, skills, and potential of Oriental Mindoreños, while also recognizing the significant contributions of our former leaders, thereby inspiring others to achieve excellence and uphold competence in their work ethic;

**WHEREAS**, in celebration of *Fiesta MAHAL TANA 2025: The 75<sup>th</sup> Araw ng Oriental Mindoro*, PGOM shall confer a total of seventy-five (75) awards under the recognition program officially titled *Pagkilala Sa 75 Simbolo Ng Natatanging Oriental Mindoreño*;

**WHEREAS**, to ensure transparent, efficient, and well-coordinated planning, selection, and implementation of the recognition program, there is a necessity to constitute a Search and Selection Committee ("SSC") to formulate the mechanics, issue the call for nominations, assess submitted nominations, and recommend to the Provincial Governor the list of seventy-five (75) awardees;

**NOW, THEREFORE, I, HUMERLITO A. DOLOR, MPA, Ph.D.**, by virtue of the powers vested in me by law as the Governor of the Province of Oriental Mindoro, do hereby order the following:

**SECTION 1. SEARCH AND SELECTION COMMITTEE.** The SSC is hereby created and shall be composed of:

**SECTION 2. FUNCTIONS OF THE SSC.** The SSC shall:

1. Initiate and coordinate all necessary activities for the successful implementation of the *Pagkilala Sa 75 Simbolo Ng Natatanging Oriental Mindoreño*;
2. Issue the call for nominations; receive, log, and verify completeness of submissions;
3. Deliberate on qualified nominations and formulate/finalize the detailed criteria, qualifications, and guidelines (including residency requirements and analogous concerns) consistent with this Executive Order;
4. Prepare and recommend to the Provincial Governor the list of seventy-five (75) awardees for concurrence;
5. Determine and propose the budgetary requirements for the implementation of the recognition program; and
6. Undertake other tasks and functions as may be necessary for the conduct of the program.

**SECTION 3. CATEGORIES.** The recognition shall be conferred under *Pagkilala Sa 75 Simbolo Ng Natatanging Oriental Mindoreño* and shall comprise four categories:

1. **MANGYAN.** This category recognizes individuals who uplift their communities through leadership, public service, academic excellence, sports, and technical expertise. The awards in this category shall consist of the following:
  - Excellence in Leadership and Governance
  - Excellence in Public Service
  - Excellence in Student/Youth Development
  - Excellence in Sports and Athletics
  - Excellence in Engineering and Architecture
  - Excellence in Agricultural and Veterinary Services
  - Excellence in Judicial and Legal Services
2. **HALCON.** This category honors exceptional excellence and impact across culture and the arts, innovation and research, medicine, business and entrepreneurship, media and communication, and education. The awards in this category shall consist of the following:
  - Outstanding Cultural and Artistic Achievement Citation
  - Outstanding Innovation and Research Citation
  - Outstanding Medical Service Citation
  - Outstanding Business Leadership Citation
  - Outstanding Entrepreneurship Citation
  - Outstanding Media and Communication Citation
  - Outstanding Educator Citation

3. **TAMARAW.** This category recognizes significant contributions through volunteerism, advocacy, and humanitarian efforts—including women's empowerment; the rights of persons with disabilities (PWD) and LGBTQIA+ communities; environmental protection; the safeguarding of religious values; and disaster resilience. The awards in this category shall consist of the following:

- Honor in Volunteerism and Humanitarian Service
- Honor in Women Empowerment
- Honor in PWD Advocacy
- Honor in LGBTQIA+ Advocacy
- Honor in Environmental Advocacy
- Honor in Religious Protection
- Honor in Disaster Resilience Advocacy

4. **NAUJAN LAKE (POSTHUMOUS).** This category honors individuals whose lifetime contributions leave a lasting legacy.


**SECTION 4. PROCESS FLOW.** To ensure clarity and accountability, the SSC shall observe the following process:

1. Submission of nomination forms with complete attachments;
2. Deliberation on eligible nominations;
3. Recommendation to the Provincial Governor of the proposed list of awardees; and
4. Concurrence by the Provincial Governor of the final list.

**SECTION 5. FUNDING.** All expenses incurred in the implementation of the *Pagkilala Sa 75 Simbolo Ng Natatanging Oriental Mindoreño* shall be charged to the budget of PGOM, subject to existing accounting and auditing rules and regulations.

**SECTION 6. EFFECTIVITY.** This Executive Order is effective immediately and shall apply solely to the implementation of the *Pagkilala Sa 75 Simbolo Ng Natatanging Oriental Mindoreño*, in line with the celebration of *Fiesta MAHAL TANA 2025: The 75<sup>th</sup> Araw ng Oriental Mindoro*.
